TIMELINE

- **1982** Keith Haring invited to Australia by John Buckley, the inaugural director of the soon to be opened Australian Centre for Contemporary Art.
- **1984, 18 February 8 March** Keith Haring visits Australia and during his stay paints a mural on the exterior wall of the Collingwood Technical College at 35 Johnston Street on 6 March.
- **1996** Some conservation work undertaken by Melbourne company, Artcare. Recommended maintenance program not undertaken by State Government.
- 2002 T. Gott, & L. Sullivan, 'Keith Haring in Australia', Art & Australia, Vol. 39 #4, 2002
- **2004 -** Through an application made by the City of Yarra, the mural becomes Heritage Listed (VHR# H2955).
- **2008 Ongoing** Hannah Mathews and Wendy Bignami meet through a shared interest in the Keith Haring mural in Collingwood. They being researching its history and advocating for its future care.
- **2009, 12 April -** Hannah Mathews and Wendy Bignami meet with the City of Yarra to discuss their concern about the mural's future. They draw the City's attention to the activity of the Keith Haring Foundation and their key role as the custodians of Keith's wishes and interests. The Keith Haring Foundation advocates the repainting of Keith's works at their original sites and has advised on a number of similar repainting projects.

- **2010 Ongoing** The Haring Working Group meets with City of Yarra and Arts Victoria to discuss the way ahead for the mural's care.
- **2010, 14 October** The Keith Haring Working Group Meets.

- **2010, 19 October** Arts Victoria and RBA Architects release draft version of the Conservation Management Plan (CMP) to members of the Keith Haring Working Group for feedback.
- **2010, November December** Members of Keith Haring Working Group provide individual feedback to the CMP. Letters requesting the wishes of the artist, as represented by the Keith Haring Foundation, be respected are also submitted to Arts Victoria from a number of contemporary art world figures in Australia and overseas.
- **2011, 3 March** John Buckley Gallery screens the film 'BABIES, SNAKES AND BARKING DOGS: KEITH HARING IN AUSTRALIA'.
- **2011 April -** Arts Victoria and RBA Architects release final Conservation Management Plan which recommends the mural's preservation in current deteriorated state.
- **2011, 2 June** H. Mathews, 'Fade to Grey: On the future of Keith Haring's Collingwood mural', *Art & Australia*, Vol. 48 #4, 2011
- **2011, 2 July** G. Coslovich, 'Does this need a repaint? Yes and No', *The Age*, 2 July, 2011
- **2011, 5 July** B. Sefton, 'Million Dollar Graffiti Wall: Baillieu saves Collingwood street art', *Vexnews.com*, 5 July, 2011
- **2011, 26 July** The Keith Haring Working Group Meets.
- **2011, 26 July** Keith Haring Foundation reject CMP recommendations and request Arts Victoria find a way to repaint the mural at its original site.
- **2011, 22 September** Arts Victoria and Lovell Chen Architects submit redevelopment plans for entire site for planning approval. These include an updated gate entrance to the site in front of mural, combined pedestrian and vehicle access to site in front of the mural, location of car parking spaces opposite mural and landscaping that prevents a dedicated viewing area for the mural on site.
- **2011, 3 October** Deadline for lodgement of public objections to site plans.

Imminent -Arts Victoria's application for a permit to undertake preservation works on the mural soon to be submitted to Heritage Victoria. Last chance for public objection!
